Terms and Conditions of Trade

1. Credit Terms

All invoices must be paid in full within 30 days from the invoice date, unless otherwise agreed in writing. Overdue accounts may be placed on hold without notice.

2. Title and Risk

Ownership of goods remains with Australian Filter Sales until full payment is received.

Risk in goods passes to the buyer upon delivery.

3. Default and Collection Costs

If payment is not received by the due date, the customer agrees to pay all reasonable costs associated with the recovery of the debt, including collection fees, legal expenses, court costs, and interest on overdue amounts at 2% per month.

4. Returns and Claims

Claims for credit, discrepancies, or damaged goods must be made within 7 days of delivery.

Goods must be returned in original condition and packaging.

A restocking fee may apply. Special-order or custom-made products are non-returnable.

Freight for returned goods is at the customer's expense unless the return is due to damage or an error by Australian Filter Sales.

5. Limitation of Liability

Australian Filter Sales shall not be liable for any indirect or consequential loss or damage resulting from the supply or use of products. Liability is limited to the repair, replacement, or refund of faulty goods, at our discretion.

6. Pricing and Freight

Prices are subject to change without notice. Freight charges may apply to some orders, including non-stocked or oversized items. Any pricing errors will be corrected, and the customer will be notified before processing.

7. Personal Guarantee

Where the applicant is a company or trust, the directors or trustees signing this form personally guarantee all debts incurred by the applicant and indemnify Australian Filter Sales in the event of non-payment.

8. Privacy and Credit Checks

The applicant authorises Australian Filter Sales to collect and use information to assess creditworthiness, including conducting credit checks and sharing information with collection agencies if required.

9. Force Majeure

Australian Filter Sales will not be liable for any delays or inability to deliver due to events beyond our control, including but not limited to natural disasters, strikes, transportation issues, or supplier shortages.
